This volume is the result of something over nine years' work by a large number of people. The data, which form the core of the book, have been collected over a much longer period, by considerably more people: many hundreds of amateur and professional ornithologists, birdwatchers, conservationists and others interested in the birds and wider environment of the African region. It is clearly impossible to acknowledge them all here, but without their contributions it would not have been possible to identify the Important Bird Areas in Africa and its associated islands.

It has been a privilege and a pleasure, in the course of compiling this volume, to have been able to work with a large number of African ornithologists and others expert in the birds of the region, who have collaborated enthusiastically and patiently to compile national inventories, complete database forms, write country chapters and act as national Important Bird Area coordinators. The network of staff and volunteers of the BirdLife International Partnership in Africa has been intimately involved throughout. One particularly gratifying aspect of the programme has been the increasing degree to which a rapidly expanding group of young African ornithologists have contributed to the programme, and continue to do so, both within the BirdLife network and beyond.

We are very grateful to the funders of this project and to the BirdLife Partners and others who have invested substantial resources into the collation and checking of data nationally. We particularly wish to thank the Royal Society for the Protection of Birds (RSPB), the BirdLife Partner in the United Kingdom, who funded the project coordinator's post for six years, provided much additional support for project coordination throughout this time and have contributed to the costs of the production, launch and advocacy of this book. This is in addition to the sustained funding they have provided to several BirdLife Partners in Africa, a significant element of which has gone into resourcing the national Important Bird Area programmes in these countries, some of the results of which are included here. The RSPB has also provided significant funding for the development of the World Bird Database. The support of Mark Avery, Alistair Gammell, David Gibbons and Dieter Hoffmann in arranging this funding is gratefully acknowledged.

Illuminating discussions on, and help with, taxonomic issues, threatened species, threatened species categories, species of restricted range and the European IBA programme were held with Nigel Collar, Ali Stattersfield, Mike Crosby and Melanie Heath. Numerous people made comments and provided advice on the biome divisions and the associated biome-restricted assemblages recognized in this work. These include, in addition to members of the Steering Committee, Keith Barnes, Sue Childes, Richard Dean, Frank Hawkins, Peter Mundy, Bob Dowsett and, especially, Françoise Dowsett-Lemaire. Although the process is not yet complete, a significant proportion of the data in this book has been incorporated into the IBA database module of BirdLife's World Bird Database. The editors are extremely grateful for the considerable help received with the introductory chapters.
