Major inconsistencies or loopholes detected (if yes please describe): Article 1 of MD 101/2002 states that 'exempt of the ban on killing, hunting and catching, are wild animals and birds that prove to bear or cause diseases, or that pose a real danger to individuals or property. Under these circumstances, the Ministry is permitted to kill or hunt these species, or to grant permits to do so for specialised entities (unofficial translation from Arabic).

Royal Decree 114/2001 (Article 33) states that 'Whoever harms or spoils () wildlife () by poaching or killing or in any other manner shall be punished with the following: a) Imprisonment for a term not less than 6 months and not exceeding 5 years and with fine not exceeding RO 5000 and not less than RO 1000 or with any of these two penalties in the event of killing or poaching
